1. Reference: Section VI – Conclusions and Recommendations – Conclusion No. 7

Columbia Chapter) ("BCSEA SCBC") on Evidence

- 1.1 Please confirm that the conclusion contemplates that the Terasen Utilities finance the "extended repayment terms" to which Conclusion No. 7 refers.
- 1.2 If so, please confirm that the "extended repayment terms" to which Conclusion No. 7 refers result in increased risk of non-repayment to ratepayers.

2. Reference: Exhibit JJP-3

- 2.1 Please provide public sources for all data used in Exhibit JJP-3, with the exception of the Terasen Utilities data.
- 2.2 Please correct the unit of measure for each utility in the "Savings", and "Sales" column, as GJ is incorrect. In the case of the Terasen Utilities, it would appear that the unit of measure should be PJ.
- 2.3 Please provide any recalculations resulting from the above.
- 2.4 Please confirm that although the "Cost" and "Savings" indicated for the Terasen Utilities are for TGI and TGVI combined, the "Sales" and "Savings % of Sales" are for TGI alone.
- 2.5 Please recalculate the "Sales" and "Savings % of Sales" using the combined TGI and TGVI numbers.
- 2.6 The Terasen Utilities' proposed EEC portfolio does not include any custom projects or any EEC activity for industrial customers, including industrial process efficiency. Rather, the Terasen Companies' Non-Residential EEC activity is activity related to Commercial and Institutional buildings. However, in the case of at least one of the other utilities detailed in Exhibit JJP-3, Union Gas, the Non-Residential Activity includes custom projects for "Distribution Contract" customers, and in fact, this program area provides the largest proportion of savings in the "Non-Residential" figures for Union Gas. In order to compare like to like, please re-calculate the findings for the "Non-Residential" sector for Union Gas excluding any activity that is not activity related to Commercial and Institutional buildings. Please do the same for all the other utilities in Exhibit JJP-3 where the "Non-Residential" figure include activity not related to Commercial and Institutional buildings, excluding such activity. Please show all recalculations and provide publicly available sources for all data used in the calculations.
