Application for Approval of a Code of Conduct (COC) and Transfer Pricing Policy (TPP) for Affiliated Regulated Businesses Operating in a Non-Natural Monopoly Environment (ARBNNM)

FEI Summary of Participants' Positions for the Pre-Hearing Conference

On June 27, 2014, FEI filed the application noted above (the Application) with the British Columbia Utilities Commission (the Commission).

After submissions from the parties, the Commission issued a letter dated August 18, 2014 (Exhibit A-3) setting a Pre-hearing Conference and identified matters for which it invites all parties to speak at the Pre-hearing Conference.

The Panel sought written submissions from FEI on items (5) and (6) which are being filed under separate cover.

Further, the Panel indicated it would be seeking confirmation from participants at the Prehearing Conference that they are in agreement with FEI's characterization of the sections in the COC and TPP documents that are (i) accepted, (ii) significant differences remain, or (iii) general agreement or less significant differences.
