## ORDER NUMBER G-33-18

IN THE MATTER OF the *Utilities Commission Act*, RSBC 1996, Chapter 473

### **ORDER**

### WHEREAS:

- A. On December 14, 2017, FortisBC Energy Inc. (FEI) filed its 2017 Long Term Gas Resource Plan (LTGRP) for acceptance by the British Columbia Utilities Commission (Commission), in accordance with section 44.1(2) of the *Utilities Commission Act*;
- B. FEI's 2017 LTGRP presents FEI's long term view of the demand-side and supply-side resources identified to meet expected future natural gas demand and reliability requirements taking into consideration the cost to FEI's customers over the 20-year planning horizon (2017-2036). The 2017 LTGRP includes a 20-year vision for FEI and culminates in an Action Plan that describes activities that FEI intends to pursue over the next four years;
- C. In order to inform the 2017 LTGRP, FEI offered stakeholders the opportunity to participate in discussions including, but not limited to, workshops with a resource planning advisory group, community engagement workshops and dialogue with First Nations, industry associations and other advisory groups;
- D. FEI's previous LTGRP, the FortisBC Energy Utilities 2014 Long Term Resource Plan, was accepted by the Commission by Order G-189-14 on December 3, 2014;
- E. Section 44.1(5) of the *Utilities Commission Act* provides that the Commission may establish a process to review long term resource plans; and
- F. The Commission considers that a public hearing process for the review of FEI's 2017 LTGRP is warranted and that a regulatory timetable should be established.

**NOW THEREFORE** pursuant to section 44.1(5) of the *Utilities Commission Act*, the Commission orders as follows:

- 1. A written public hearing process is established for the review of the FortisBC Energy Inc. (FEI) 2017 Long Term Gas Resource Plan (Application) in accordance with the regulatory timetable set out in Appendix A to this order.
- 2. By no later than February 23, 2018, FEI is to publish the Public Notice attached as Appendix B to this order, in display-ad format, in the appropriate local news publications to provide adequate notice to the public.
- 3. As soon as is reasonably possible, FEI is directed to publish the Application, this order, and the regulatory timetable on its website and to provide a copy of the Application and this order to:
  - a. All invitees and attendees of the stakeholder engagement process outlined in Section 7 of the Application; and
  - b. Registered interveners and interested parties in the:
    - i. FortisBC Energy Utilities 2014 Long Term Resource Plan proceeding;
    - ii. FEI 2017 Price Risk Management proceeding; and
    - iii. FEI Annual Review for 2018 Delivery Rates proceeding.
- 4. Interveners who wish to participate in the regulatory proceeding are to register with the Commission by completing a Request to Intervene Form, available on the Commission's website at <a href="http://www.bcuc.com/get-involved/get-involved-proceeding.html">http://www.bcuc.com/get-involved/get-involved-proceeding.html</a>, by the date established in the regulatory timetable attached as Appendix A to this order, and in accordance with the Commission's Rules of Practice and Procedure attached to Order G-1-16.
